

# Highlights: 2023 VRWJPO Annual Activity & Financial Report

#### **Our Mission**

To collaboratively provide education, science, and support to restore and protect the Vermillion River Watershed's natural resources for all who live, work, and play within its boundaries.

## **Who We Are**

The Vermillion River Watershed Joint Powers Organization (VRWJPO) was founded in 2002 by a joint powers agreement between Dakota and Scott counties. It is the largest watershed in the Twin Cities Metro area at 335 square miles, with 20 cities and townships represented and 49 miles of DNR-designated trout streams.

## **Getting Results**

Monitoring results have shown consistent improvements and stability in local environmental resources. This reflects VRWJPO's Capital Improvement Program efforts to reduce pollutants and promote healthy habitats.

- All six of the regularly monitored lakes in the watershed show improvements in phosphorus levels, and five of six show improvements in water transparency since 2007.
- Habitat conditions along the Vermillion River and major tributaries are stable, with all but one at "good" or "fair" scores from the MPCA.


2023 projects funded by VRWJPO are estimated to reduce pollution entering waterbodies by:

- 795 tons per year total suspended solids
- 774 pounds per year phosphorus
- 3,951 pounds per year nitrate



Grants from Minnesota Clean Water, Land & Legacy Amendment funds make many of these projects possible.

## Developing the Next Watershed Plan

VRWJPO began developing the 2026-2035 Watershed Management Plan. We consulted with Twin Cities-based planning firm HKGi and began hearing from stakeholders what they'd like to see us work on in the next ten years.

We gathered feedback through:

- Direct outreach to local stakeholders
- Initial planning meeting in October
- Tabling at Brand Farms, Empire
- Virtual stakeholder meetings
- Online and paper surveys
- Displays at libraries in Elko New Market, Hastings, and Lakeville; and at Lebanon Hills Regional Park and Whitetail Woods Regional Park


## **Noteworthy Activities**
